

Outcast Jazz Band

This document shall serve as an agreement between the **Outcast Jazz Band**, herein referred to as **OJB**, and _____, herein referred to as "**PURCHASER**", for the engagement described below.

A performance will be given by the **OJB** on / / (DATE) at _____, (LOCATION AND ADDRESS). A show of _____hrs (LENGTH) will be performed from ____pm-____pm. Performance shall include a break of approximately 15 minutes per hour. A fee of *\$_____ has been agreed upon. A nonrefundable deposit of \$500 is required upon acceptance of these terms, with the balance being paid to Vince Clark immediately following the performance. All sound equipment pertaining to the band shall be provided by the **OJB** unless specified below. Band shall arrive for setup approximately 1.5 hours prior to starting time. Alternate setup schedule may be negotiated at the rate of \$75/hr. Access to adequate electrical source, 2 separate 20amp circuits, is required. In addition, we will need 5 armless chairs because saxophonists are inherently lazy.

PLEASE READ CAREFULLY!!

In the event of a delayed starting time beyond control of the band, performance shall last only until the time stated above, with full payment always required. Additionally, purchaser shall assume full financial liability in the event of cancellation less than 30 days prior to performance. Alternate starting time shall be negotiated at least two days prior to performance, with any overtime negotiated prior to end of said performance. Overtime rate is time and a half. All Downtown Chicago engagements will be subject to an additional \$160 parking surcharge. We request meals for any member who is required to be on the premises for longer than 5 hrs. OJB expects open bar when applicable, and will not abuse the privilege unless we're in an especially good mood.
